Joint Health and Safety Taskforce Bulletin

Employers, unions, and workers in the K-12 public education sector are committed to workplace safety and the prevention of workplace violence. A vital part of violence prevention is ensuring that school districts develop, maintain, and communicate effective Individual Safe Work Instructions (ISWI). ISWIs provide specific and detailed guidance to workers on potential risks, and how to safely interact or work with students whose behaviour or care needs may pose an ongoing risk to workers.

Best Practices for Individual Safe Work Instructions (ISWIs)

To support school districts in this important work, the Joint Health and Safety Taskforce has developed a new resource, *Best Practices for Individual Safe Work Instructions (ISWIs) in K-12 Education,* for developing, maintaining, and sharing Individual Safe Work Instructions. Which includes the following:

- 1. Collaborative development
- 2. Dedicated internal collaboration time
- 3. Identify and assess the risk
- 4. Identify, assess, and implement risk prevention and mitigation strategies
- 5. Ensure the ISWI is clear, comprehensive and consistent
- 6. Education, training and professional development
- 7. Document and communicate ISWIs
- 8. Monitor and evaluate effectiveness
- 9. Regularly review and update ISWIs
- 10. Maintain confidentiality
