## **Constitutional Amendments**

### **Constitutional Amendment No C9**

CUPE will Amend the CUPE National Constitution that there will be no registration fee for retirees of chartered organization and each chartered organization may register one retiree who will be seated at the convention together with the chartered organization and have a voice but no vote. **DEFEATED** 

#### **Constitutional Amendment No C24**

A local Union can amend or add to its bylaws only if the amended or additional bylaw do not conflict with the Constitution because a minimum of 30 days is enough to advise member s of upcoming changes. **PASSED** 

#### Constitutional Amendment No C2

Regarding representation to convention:

Each chartered organization may register one additional delegate who self-identifies as a member of one of the following communities: Indigenous, 2SLGBTQI+, racialized, women, workers with disabilities, young workers.

#### Resolutions

#### Resolution No. 235:

CUPE will promote more equitable access, opportunities, and leadership roles to increase the representation of women and gender diverse people at all levels of union leadership.

#### **PASSED**

#### Resolution No. 113:

CUPE will endorse, support and implement concrete actions of the Boycott, Divestment, and Sanctions (BDS) campaign calling for freedom, justice and equality for the Palestinian people, and an end to Israel's regime of settler colonialism, apartheid, and occupation.

**NOTE**: Contentious issue that required a secret vote. Many people got up to speak against this resolution calling it antisemitic while others claimed it was justified and that Israel was committing genocide. Several people got up and to say they no longer felt "safe" in the convention hall with this topic. Very passionate speakers followed. This resolution was voted on and was revealed the following morning.

This resolution was **DEFEATED** with 846 against, 642 for and 43 spoiled ballots.
